Announcement on the Resolution of the Board of Directors

The twenty-eighth meeting of the second session of the board of directors (the “**Board**”) of China Construction Bank Corporation (the “**Bank**”) was held in Beijing on 28 January 2010. 17 directors were eligible to attend the meeting, of whom 12 directors presented in person. Mr. Gregory L. Curl, director, has appointed and authorized Mr. Chen Zuofu, director, as his proxy to attend and vote on his behalf. Ms. Jenny Shipley and Mr. Peter Levene, directors, have appointed and authorized Mr. Song Fengming, director, as their proxy to attend and vote on their behalf. Ms. Elaine La Roche and Mr. Wong Kai-Man, directors, have appointed and authorized Mr. Tse Hau Yin, Aloysius, director, as their proxy to attend and vote on their behalf. The meeting was chaired by Mr. Guo Shuqing, chairman of the Board. The meeting was convened in accordance with the provisions of the *Company Law of the People's Republic of China* and the *Articles of Association of China Construction Bank Corporation*.

The proposal of nominating candidate for the executive vice president position of the Bank was passed at the above meeting by the Board.

The voting results of this proposal were as follows:

voted in favour: 17 votes; voted against: 0 vote; abstained from voting: 0 vote.

It was resolved at the above meeting that Mr. Pang Xiusheng be appointed as an executive vice president of the Bank.

The Independent Directors of the Bank agreed on this proposal.

Mr. Pang Xiusheng, aged 51, a PRC national, has served as the chief financial officer of the Bank since April 2006. Mr. Pang was executive vice chairman of the Bank’s asset and liability committee from March 2006 to April 2006; director of the Bank’s restructuring office from April 2005 to March 2006; general manager of Zhejiang Branch of China Construction Bank from June 2003 to April 2005, and acting general manager of Zhejiang Branch of China Construction Bank from April 2003 to June 2003. Mr. Pang served consecutively as deputy general manager of treasury

and planning department, deputy general manager of planning and finance department, and general manager of planning and finance department from September 1995 to April 2003. Mr. Pang is a senior economist and recipient of a special grant from the PRC government. He received his master's degree in technological economics from Harbin Industrial University in 1995.

As at the date of this announcement, Mr. Pang is not holding any equity interest in the Bank, nor is he connected with the Bank's directors, supervisors, senior management, major shareholders or controlling shareholders. In respect of Mr. Pang's appointment, no other issue shall be brought to the attention of the shareholders of the Bank. Mr. Pang's appointment is subject to the approval of the China Banking Regulatory Commission.

In addition, Ms. Xin Shusen has resigned from her position as executive vice president of the Bank. According to work arrangement, Ms. Xin Shusen will continue to serve as an executive director of the Bank.

The Board would like to express its sincere gratitude to Ms. Xin Shusen for her contributions to the Bank as an executive vice president of the Bank.
